# NOTICE TO REAL PROPERTY TAXPAYERS

Real Property Taxpayers are advised to pay real property tax on lands, improvements and machinery this Calendar Year 2024.

Real Property Taxpayers paying on quarterly basis can pay their quarterly payments without interest if payment is made on or before the dates stated as follows:

No interest if quarterly payment is made on the following dates:

<b>FIRST QUARTER</b>	<b>On or before March 31, 2024</b>
<b>SECOND QUARTER</b>	<b>On or before June 30, 2024</b>
<b>THIRD QUARTER</b>	<b>On or before September 30, 2024</b>
<b>FOURTH QUARTER</b>	<b>On or before December 31, 2024</b>

However, if quarterly payment is made on the following dates, there will be a 10% Discount in addition to no interest:

<b>FIRST QUARTER</b>	<b>On or before January 1 to 20, 2024</b>
<b>SECOND QUARTER</b>	<b>On or before April 1 to 20, 2024</b>
<b>THIRD QUARTER</b>	<b>On or before July 1 to 20, 2024</b>
<b>FOURTH QUARTER</b>	<b>On or before October 1 to 20, 2024</b>

Payment will be accepted at the Real Property Tax Division, Office of the City Treasurer, Parañaque City Hall, San Antonio Valley I. Payment should be in Cash or Manager's Check.

City Treasurer's Office is open Mondays to Fridays, and Saturdays from January to March to accommodate first quarter deadline.
