NOTICE TO REAL PROPERTY TAXPAYERS

Real Property Taxpayers are advised to pay real property tax on lands, improvements and machinery this Calendar Year 2024.


Real Property Taxpayers paying on quarterly basis can pay their quarterly payments without interest if payment is made on or before the dates stated as follows:

No interest if quarterly payment is made on the following dates:

FIRST QUARTER SECOND QUARTER THIRD QUARTER **FOURTH QUARTER**

On or before March 31, 2024 On or before June 30, 2024 On or before September 30, 2024 **On or before December 31, 2024**

However, if quarterly payment is made on the following dates, there will be a 10% Discount in addition to no interest:



On or before January 1 to 20, 2024 On or before April 1 to 20, 2024 On or before July 1 to 20, 2024 On or before October 1 to 20, 2024

Payment will be accepted at the Real Property Tax Division, Office of the City Treasurer, Paranaque City Hall, San Antonio Valley I. Payment should be in Cash or Manager's Check.

City Treasurer's Office is open Mondays to Fridays, and Saturdays from January to March to accommodate first quarter deadline.
