The spirit of Bayanihan keeps the lights on

The Interruptible Load Program (ILP) is a voluntary demand-side management program of the Department of Energy (DOE) and the Energy Regulatory Commission (ERC) which calls on big power consumers to temporarily de-load from the grid when there is insufficient power supply.

This April, the National Grid Corporation of the Philippines raised the alarm that power supply for the Luzon grid was insufficient to meet consumer demands and power outages may be imminent.

With this, companies heeded Meralco's call to participate in the ILP, so that power interruptions, including to millions of households, were avoided as businesses voluntarily shut down non-essential equipment and operations, shifted to generators, and lessened their electricity usage.

Our sincerest appreciation goes out to all our ILP partners.

Commitment reached a peak of 352MW*, which was enough to spare as many as 2.3M* households from power outages during the Red Alerts on April.


